## District Administrator Vacancy – Chair Overson

## Consideration of Expenditures to Assess Construction Costs – Assistant Chief Burchett

AC Burchett is requesting approval to spend \$1,250,000 for pre-construction costs for all 7 stations. This assessment will allow Construction Control Company (CCC) to identify costs in order to accurately determine total project costs & keep timelines moving forward.

If approved, the RFP will be sent this week and will be awarded once the budget amendments are completed and approved. Council Member Henderson asked about how their intent to leave will effect this amount. AC Burchett stated that this amount is the worst case scenario and would be adjusted accordingly.

## <u>Darkhorse Software Update</u> – Assistant Chief Burchett

AC Burchett has started meeting with the municipalities and asked those who he has given the demo to for feedback. Mayor Silvestrini stated that it was a "fantastic tool" and the exercise made evident that there are considerations that must be addressed prior to building Station 112.

Council Member Stewart felt that developing a relationship with each municipalities planning departments will result in a more functional design that improves response times, when building out new areas.

AC Burchett stated that the more the software is utilized, the more application value. Mayor Overson asked what value the software holds for areas that are established. Chief Petersen hopes to look at areas with higher response times to find a solution that would make a substantial difference with a regional resource with little to no additional operating costs. An example would be additional companies, peak-load placement, etc. This software will better answer the questions of how to obtain improved services.

Council Member Stewart asked that this software be considered for transferral to UFA. Chief Petersen stated that this was the original proposal and the intent going forward, this is the first year of use and if the value is there, it is slated to appear in the UFA Budget for approval.

## Training Facility Land Transfer – Counsel Anderson/Assistant Chief Burchett

Counsel Anderson is requesting approval to transfer the Training Facility to UFA and allow UFA to negotiate with Ivory Homes. The facility would then remain a UFA asset.

More work is pending regarding a Revision Clause as discussions are already taking place with SLCo. Mayor Silvestrini asked that Counsel Anderson verify that there is no trigger for the Revision Clause. Associate Deputy Mayor Reberg stated that SLCo does not see a problem, but wishes to retain the clause and will carry it through the exchange with Ivory Homes.

Mayor Silvestrini moved to approve the transfer of property from UFSA to UFA. Mayor Knopp seconded the motion.

# <u>Herriman Notice of Intent to Separate from UFSA</u> – Council Member Henderson

Council Member Henderson stated that after an extensive and very collaborative process with UFA/UFSA staff, Herriman plans to pass a resolution next week to separate from UFSA. Furthermore, Herriman is committed to remain with UFA, this is just a financial decision of how to pay for the service.

Mayor Silvestrini feels this is adequate notice, Counsel Anderson agreed that there are no timing concerns.

# Report of Workgroup Meetings Related to Riverton City Withdrawal — Counsel Anderson/CFO Hill Counsel Anderson summarized the process the workgroup undertook. The statute doesn't dictate anything other than fairness, so guidance is minimal. The option being presented from the workgroup balances competing interests. Having a policy will ensure consistency and fairness in future instances, it is not binding, but provides the framework moving forward.

Councilman Henderson stressed that he believes this policy is the right thing to do. We all agreed to be a part of the UFSA and cannot begin determining how much each other used services vs provided revenue after we committed to a partnership. He gave an example of agreeing to split the bill for dinner equally than arguing over the details because one couple ate more of the food than the other. This policy has a negative impact on Herriman and is a windfall for Riverton, however, Councilman Henderson supports the fact that we are all in this together and this policy allows for an amicable separation when a municipality decides it is best to pay for the UFA service in a different manner.

The Board had conversation regarding verbiage and potential scenario concerns with the policy. Chief stressed that application of this policy in the future, under different conditions, must be considered. This application of the policy with Riverton and Herriman is a close comparison, but the Board needs to look beyond this current scenario and apply it to a smaller municipality. Chief cautioned the Board about considering other scenarios beyond Riverton and Herriman for the Policy. We shouldn't want a

policy that is in place for only a few years then must be changed when the situation changes with a new request to separate.

Recommendations were made to address these concerns, it was agreed that although the policy can not be perfect, it must allow options for reviewing issues specific to the request to accommodate variables that may arise.

Council Member Stewart moved to approve the proposed UFSA Policy on Withdrawal with revisions as discussed.

- 1. Create Section D adding language stating Revisionary Clause does not apply after bond obligations are complete or construction costs are covered by payments made by municipality.
- 2. Strike final sentence Section C.
- 3. Distribution of fund balance, final bond payment be held & distribution occurs over period less bond and then final bond payment made with what is held, Section A Part 4.

Mayor Knopp seconded the motion.

He also stated that as a participant in the workgroup, this policy represents what the workgroup agreed upon.

Rachel will redraft the policy to incorporate the revisions.
